**Extended Height Gauntlet**

- Clinical Indications:
- Post fractures of the distal tibia
  - Post fractures of the ankle
  - Subtalar and midtarsal trauma
  - Heel ulcers
  - Post surgical after midfoot and hindfoot trauma
  - Charcot Foot
  - Severe ankle instability

- Trans-metatarsal amputation

  - Osteoarthritis of the subtalar and midtarsal joints

**Balance Brace**

- Clinical Indications:
- Difficulty walking and/or maintaining balance
  - History of falls
  - Vestibular disorder
  - Chronic ankle instability
  - Arthritic ankle
  - Stroke imbalance/ foot drop
  - Diabetic peripheral neuropathy

**Basic Solid Ankle AFO**

- Clinical Indications:
- Foot drop
  - Weak or absent plantar flexors/ dorsiflexors
  - Severe degenerative arthritis
  - Lateral and medial instability of subtalar joint
  - Trauma

**Articulating AFO**

- Clinical Indications:
- PTTD (Posterior Tibial Tendon Dysfunction)
  - Degenerative arthritis
  - Lateral and medial instability of subtalar joint
  - Foot drop
  - Severe pronation
  - Trauma

**Floor Reaction AFO**

- Clinical Indications:
- PTTD (Posterior Tibial Tendon Dysfunction)
  - Spina Bifida
  - Cerebral Palsy
  - Achilles tendonitis
  - Adult acquired flatfoot
  - Osteoarthritis
  - Post-polio paralysis
